1. What is a cookie?

Cookies are data placed on your computer or cell phone. They are distinguished by their unique identifiers, associated with your computers or phones. They allow you to avoid having a bad consumer experience on your favorite sites, since they remember your actions and preferences. This way, you do not have to fill in your browsing preferences each time you use the site, such as location, font, or language.

These "cookies" are stored in your computer's RAM (random access memory). They do not allow us to identify you; however, they record information relating to your computer's navigation on the Site (the pages you consulted, the date and time of the consultation, etc.) that we can read during your subsequent visits.

For all Data Processing related to the collection of cookies, Field Sales Solutions, Registered in England and Wales No: 04521294. Thus, Field Sales Solutions acts as a Processor, in the sense of the Regulation on Personal Data, and in particular the Regulation (UK) 2018 on the protection of individuals regarding the Processing of Personal Data and on the free movement of such Data (GDPR).

Field Sales Solutions attaches the greatest importance and care to the protection of privacy and personal data, as well as to the respect of the provisions of the applicable Legislation.

This Cookie Policy (hereinafter the "Policy") is intended to provide you with simple, clear information about how your Data is collected through cookies placed on the Internet.

2. Are cookies placed when you browse the website?

When you first visit the Website, a banner informs you of the presence of these cookies and invites you to indicate your choice. The cookies requiring your consent in accordance with the regulations are deposited only if you accept them. You can at any time inform yourself and configure the cookies to accept or refuse them by going to the Cookie Management page at the bottom of each page of the site or by configuring your browser.

3. What data is collected through cookies?

All data relating to a terminal at a given moment can be collected via cookies, in particular

- One or more technical identifiers that identify your Internet box
- The date, time and duration of connection of a terminal to a Website.
- The Internet address of the page from which the terminal accesses the Website.
- The type of operating system of the terminal (e.g. Windows, MacOs, Linux, Unix, etc.).
- The type and version of the browser software used by the terminal (Internet Explorer, Firefox, Safari, Chrome, Opera, etc.).
- The brand and model of the mobile device or tablet.
- Possible download errors.
- The language of the browser software used by the terminal.
- The characteristics of the content consulted and shared.



4. What are the purposes of the collected cookies?

On the site, we may set different types of cookies for different purposes:

- Cookies necessary for the personalization and operation of the website: they allow you to use the main features of the website and in particular to record information between two visits on the same device, to record session connection identifiers or even elements of personalization of the interface (choice of language or presentation). They do not require your prior consent. These cookies are essential to the proper functioning of the Site. If you refuse to accept these cookies on your terminal or browser, or if you delete the cookies stored on your terminal, you will be informed that your navigation and experience on the Site may be limited.
- Analytical cookies, statistical cookies or cookies to measure the audience of the website that allow us to know the use and performance of the audience of the site and improve its operation for our visitors, for example, to establish statistics and volumes of attendance and use of various components of the site (sections and content visited, path), in order to improve the interest and ergonomics of the site.
- The social network cookies deposited by the social networks when you share with others the contents of our Sites or let them know your opinion on these contents via an application button. These cookies are deposited only when you have expressly consented to them through the banner presented when you first connect. We have no control over the process used by these social networks to collect information about your browsing on our sites and associated and Personal Data they have. We invite you to consult their data protection policies in order to know your rights with respect to each of them, and to manage your privacy settings.
- Advertising cookies that allow us to choose in real time which advertisements to display on third-party sites. These cookies are deposited only when you have expressly consented to them through the banner presented at your first connection.

5. Who places the cookies on the website?

The entities depositing cookies on the website are:

- The editor of the site is Field Sales Solutions and Indigo are the processors, i.e. the technical service providers who process your navigation data on behalf of Field Sales Solutions
- The social network publishers that can place cookies on the website are: Facebook, Instagram, LinkedIn.

6. How to manage your consent to the placement of cookies?

The deposit of a cookie for the purpose of audience measurement, personalization of content, social networks and targeted advertising requires your prior consent. This consent is requested through the banner that appears when you first browse the site. You can choose to accept the deposit of cookies for all the purposes listed, refuse them or customize your choice. You can withdraw your consent at any time by going to the Cookie Management page at the bottom of each page of the site.

7. How to manage the cookie set up on web browsers?

You have the choice to set your browser to accept or reject all cookies, to delete cookies periodically, or to see when a cookie is issued, how long it remains valid, and what it contains, and to refuse to store it on your hard drive.

You can choose to block or disable these cookies at any time by adjusting the internet browser settings on your computer, tablet, or mobile device in accordance with the instructions established by your internet browser provider and listed on the Websites mentioned below:
